

## **Financial Resources Available to Students**

### **SKMC Scholarships and Loans**

A limited number of scholarships and loans are available to students attending Sidney Kimmel Medical College. The scholarships and loans are awarded on the basis of need unless otherwise noted. It is therefore necessary that a student file a FAFSA form, an institutional Financial Aid Application, verification worksheet, and copies of parents' federal income tax returns in order to be considered for these funds. Awarding of all institutional scholarships and loans is based on demonstrated financial need, adherence to program specifications, and availability of funding. A description of each scholarship and loan is listed below (\* Descriptions reflect the language used in the scholarship agreement signed at the time of the donor gift and may contain reference to Jefferson Medical College.):

#### **SKMC Scholarship Funds\***

##### **Bernard J. Alpers, MD, Scholarship Fund**

Established in 2021, this need-based scholarship is to assist third and fourth year students with a career interest in neurology and demonstrates academic achievement.

##### **Alumni Center Scholarship Fund**

This fund was established in 2016, for the purpose of providing need-based scholarships in any of the Jefferson Colleges.

##### **David Bacharach Allman Scholarship Fund**

This fund was established in 1974 by Ann L. Allman in memory of her husband, David Bacharach Allman, MD, Class of 1914, a Past-President of the American Medical Association and Jefferson Medical College Alumni Association, to aid one or more worthy medical students each year.

##### **Alumni Association Scholarships**

Annual alumni giving donations designated as scholarships provide funds to deserving students.

##### **William J. Antognoli, MD '61 Scholarship Fund**

Established in 2014, the fund shall be used to provide scholarship support to students with demonstrated financial need. Preference given to residents of Northeastern Pennsylvania and/or students who have completed their undergraduate work at the University of Scranton.

##### **Dr. William V. Arnold, MD, PhD and Dr. Anne Romanic Arnold, PhD Scholarship Fund**

This fund was established in 2017, for the purpose of providing scholarships to students with financial need.

##### **Bachow Family Medical Scholarship Fund**

This fund was established in 2016, for the purpose of providing merit-based scholarships to first year students with preference given to students from Florida with exceptional credentials. Award is renewable for up to 4 years as long as the students maintain their academic eligibility.

##### **The Robert L. Barchi, MD, PhD Scholarship Fund**

This scholarship fund within Thomas Jefferson University is to benefit Jefferson Students who meet the criteria of demonstrated financial need and exceptional progress toward the fulfillment of their degree. Preference will be given to TJU Dual Degree students.

##### **Nicholas J. Barna, MD Scholarship**

Established in 2011, this scholarship is to assist student who continue to make satisfactory progress toward his/her degree and exhibit the greatest financial need.

#### Dr. Albert C. Barnes Scholarship Fund

The Dr. Albert C. Barnes Scholarship Fund was established in May 1967, by will of Larry L. Barnes to be used for scholarships.

#### Martha W. Barrett Scholarship Fund

Established in 2006 to assist needy medical students.

#### Dr. and Mrs. S. A. Barrett '34 Scholarship Fund

Established in 1983, this scholarship is awarded, with preference, to residents of North Carolina on the basis of academic standing first, and need second.

#### Adnan Bashir, MD Scholarship Fund

Established in 2013, this scholarship is to be awarded to a student in Jefferson Medical College with demonstrated financial need and making satisfactory progress toward their degree.

#### Warren C. Batroff Scholarship Fund

This scholarship was established in 1974 under the will of Warren C. Batroff. Students must have completed their first year of medicine and have substantial need and high scholastic standing.

#### The Baxter Family Scholarships

Established in 2015, this gift is to support scholarships for incoming students who meet the definition of underrepresented in medicine minorities, with a preference for students from the Philadelphia region. The scholarship will provide full tuition for each student for his/her four years of medical school training.

#### Dr. James D. and Jennie M. Beach Memorial Scholarship

This fund was established in 1993 to provide scholarships to deserving male and female students without regard to financial resources of such students and without consideration of need. Awards are based on academic merit, demonstrated institutional commitment, and/or community service.

#### Carl E. Becker, MD Scholarship Fund

The fund was established in 2012 by Carl E. Becker, MD '94 to provide aid to a Jefferson Medical College student with demonstrated financial need. Preference should be given to a student planning to pursue the specialty of orthopedic surgery.

#### Dr. Samuel Ludwig Beck Scholarship Fund

This fund was established in 1963 by bequest of Aida M. Houston as a memorial to her grandfather, Samuel Ludwig Beck, MD, Class of 1828, to provide scholarship aid to worthy young men who are deserving of, and are in need of, financial assistance.

#### J. Edward Berk, MD '36 Scholarship Fund

This fund was established in 2009 for the purpose of assisting medical students who demonstrate financial need and who are also making satisfactory progress toward their degree.

#### Alan Binnick, MD '73 Scholarship Fund

Established in 2021, this renewable scholarship will assist a student who is interested in practicing medicine in a rural area.

#### John and Marion M. Bilawckas Aid Fund

This fund was established in 1980 to provide scholarships for needy students at Jefferson Medical College.

#### George Fritz Blechschmidt, MD Endowed Scholarship

Established in 2013, this scholarship is to be awarded to a student in Jefferson Medical College with greatest amount of financial need..

#### Walter William Brand Memorial Fund

This fund was established in 1964 by bequest of Madeleine B. Watts as a memorial to her father, Walter William Brand, MD, Class of 1894, to aid needy and deserving students.

#### Regina K. Branigan Scholarship Fund

Established in 2015 to provide financial support to students with demonstrated financial need. Preference will be given to female students.

#### David A. Brent, MD Scholarship Fund

Established in 2011, this scholarship is to benefit a medical student(s) who demonstrates financial need and demonstrates academic ability by receiving an "Honors" designation after their first year of study.

#### Lawrence H. Brent, MD Scholarship Fund

Established in 2011, this scholarship is to benefit a medical student(s) who demonstrates financial need and demonstrates academic ability by receiving an "Honors" designation after their first year of study.

#### Lillian H. Brent, MD Scholarship Fund

Established in 2011, this scholarship is to benefit a medical student(s) who demonstrates financial need and demonstrates academic ability by receiving an "Honors" designation after their first year of study.

#### Jacob R. Brobst, MD Memorial Scholarship Fund

This fund was established in 1976 by bequest of Mrs. Alyce H. Brobst in memory of Jacob R. Brobst, MD, Class of 1915. These scholarships are to help needy students with preference given to residents of Columbia County, Pennsylvania.

#### The Paul C. Brucker Scholarship

The Stratton Foundation established this fund in 2004. This scholarship is awarded to students in the Penn State/Jefferson accelerated program in the year the student enters Jefferson. This scholarship is renewable in each year the student progresses to the next grade level.

#### Dr. Alfred E. and Rona B. Brunswick Scholarship Fund

This fund was established in 1977 by Edward B. Brunswick and Dr. Richard A. Brunswick in honor of their parents. Scholarships are awarded to financially needy medical students at Jefferson Medical College.

#### The Scott Caddy Scholarship Fund

Established in 2008, the recipients of these scholarships shall be third-year medical students who have completed or enrolled in a course in pediatrics and show a desire to set up a private practice specializing in pediatrics. It is the Trustor's desire that the beneficiaries of these scholarships be children of a physician who has passed away.

#### Clara Callahan Merit Scholarship Fund

This fund was established in 2016, for the purpose of providing merit-based scholarships to students in the Sidney Kimmel Medical College, with a preference for students participating in the Physician Shortage Area Program (PSAP) or students from rural areas and small towns intending to practice in a similar area.

#### Thomas Jerrell Carter, MD '27 Scholarship Fund

This fund was established to provide scholarship money to Jefferson Medical College students who have demonstrated a commitment or intention to serve in the Navy; or who have previously served as a Navy Medical Corpsman.

#### Beatrice Chambers Scholarship

This scholarship is awarded annually to students with demonstrated financial need.

#### The Chaudhry Family Scholarship

Established in 2009, this fund provides scholarship aid to a student in the Penn State/Jefferson accelerated program who demonstrates financial need and a history of strong academic excellence. Preference is given to a student with a history of volunteerism.

#### Franklin J. Chinn, MD '52 and Lily L. Chinn Scholarship Fund

This fund was established in 2010 by Franklin J. Chinn, Jr., MD '82; Susan E. Chinn, MD; Bertram T. Chinn, MD '87; Norman N. Chinn; and Rebecca G. Chinn, MD '93 in honor of their parents. Scholarships are awarded to a third year Jefferson Medical College student(s) on the basis of academic achievement and financial need, and are renewable in the fourth year if ongoing clinical excellence is demonstrated.

#### Esther and Arthur Cirone Endowed Scholarship

This fund was established in 2016, for the purpose of providing scholarships to students with preference to a student who is a son or daughter of a firefighter.

#### Class of 1937 Scholarship

This fund was established in 1987 to provide a Jefferson Medical College student with financial assistance in meeting his tuition payment.

#### Class of 1947 Scholarship Fund

This fund was established in memory of the deceased members of the Class of 1947. It is to be awarded to students who have achieved a high academic record and have shown a definite need for financial assistance.

#### Class of 1948 Scholarship Fund

This fund was established to provide scholarship funds to Jefferson Medical College students.

#### Class of 1957 Scholarship Fund in Honor of the Teaching Staff of Jefferson

This fund was established to provide scholarship funds to Jefferson Medical College students.

#### Class of 1958 Scholarship Fund

This fund was established in 1983 to provide financial assistance to a Jefferson Medical College student with financial need.

#### Class of 1967 Scholarship Fund

This fund was established in 2009 for the purpose of assisting medical students with demonstrated financial need.

#### Class of 1970 Scholarship Fund

This fund was established in 2008 to provide scholarships for students in Jefferson Medical College

#### Class of 1971 Scholarship

Established in 2021, this need-based Scholarship will follow one student throughout his or her four years in medical school.

#### Bessie and Stanley I. Cohen Memorial Scholarship Fund

This fund was established in 1987 by Miss Marjorie J. Cohen in memory of her parents, Bessie and Stanley I. Cohen. The scholarship is awarded each year to a student with established need.

#### Dr. Francis R. & Georgia Colangelo '84 Scholarship

Established in 2021, this need-based Scholarship will follow one student throughout his or her four years in medical school.

#### College Scholarship

This scholarship is awarded annually to students with demonstrated financial need.

#### Jerome J. Cooper Scholarship Fund

This scholarship is awarded annually to students who show outstanding all-around achievement. It was established by Elsie Cooper, in memory of her son, and Delphine Cooper.

#### Ruth Cooper Scholarship

Established in 2002, this fund provides scholarship funds to assist medical students with the direct costs of education.

#### Dr. Thomas Harold Copeland Scholarship Fund

This fund was established in 1964 by Misses Charlotte and Edna Copeland, sisters of Dr. Thomas Harold Copeland, Class of 1919, in memoriam, to aid well-qualified needy medical students, preferably on entrance into the first year.

#### Dr. Jerome M. and Florence D. Cotler Scholarship

Established in 2007 by Dr. Jerome M. and Florence D. Cotler, this scholarship is intended to provide annual equal scholarship support to two (2) Jefferson Medical College students demonstrating financial need.

#### Dr. J. F. Culler, SKMC 1886 Memorial Scholarship

Established in 1992, this fund provides scholarships to aid men and women in the study of medicine.

#### Anna Marie D'Amico, MD '72 Scholarship

Established in 2019, this scholarship be awarded each year to two students from Delaware.

#### Daitch Family Scholarship

Established in 2014, the purpose of the fund is to provide financial support in the form of scholarship awards to Sidney Kimmel Medical College students with demonstrated financial need.

#### Theodore J. Daly, MD '83 Scholarship Fund

This fund was established in 2017 for the purpose of providing scholarships to students with financial need with preference to students from the state of New York with an interest in dermatology.

#### James D. and Mary Jo Danella Family Scholarship Fund

Established in 2015 to provide financial support in the form of one or more scholarship awards to Sidney Kimmel Medical College students. Preference will be given to students who demonstrate leadership potential.

#### Drs. Harold S. and Arthur S. Davidson Scholarship Fund

This fund was established in 1981 by Mrs. Mary R. Crosby in memory of Drs. Harold S. and Arthur S. Davidson to assist Jewish medical college students.

#### Death Under Glass Scholarship Fund

Established in 2020, this need-based scholarship assists the College in achieving a diverse student body with preference to students of an underrepresented demographic population within the College.

#### Delaware State Scholarship Fund

This fund was established in 2012 by Jefferson Medical College alumni in the state of Delaware. The scholarship is awarded each year to a Sidney Kimmel Medical College student(s) from the state of Delaware with demonstrated financial need.

#### The Eleanor DePalma Scholarship

Established in 2013 and amended in 2015, this fund is awarded with preference to students who meet all or most of the following criteria: financial need, Primary Care declaration, rural or inner city background, past meaningful experience that reinforces the desire to practice Primary Care, interest or qualification in the Master of Public Health degree.

#### William E. and Martha A. Dever Memorial Scholarship

This fund was established in 1995 to assist deserving and needy students who would be unable to attend medical school because of financial need.

#### The Howard and Alice Diecker Scholarship Fund

This a scholarship fund to assist Jefferson Medical College students.

#### Dorrance NJ Scholarship

This scholarship is awarded annually to students with demonstrated financial need.

#### Dr. Alfred W. and Mignon Dubbs Fellowship Fund

This scholarship fund was established to promote the welfare and knowledge of promising students.

#### Elizabeth Dwyer Memorial Scholarship

This fund was established in 1992 to provide scholarships for students in Jefferson Medical College.

#### Eakins Legacy Fund

Established in 2007 from the proceeds from the sale of the "Gross Clinic" portrait, the purpose of this fund is to provide scholarships to students who demonstrate financial need.

#### Robert C. Eyerly, MD Walter R Edmunds DDS Fund

This scholarship is awarded to medical students/residents in the six-year Oral and Maxillofacial Surgery/SKMC Integrated Program. Preference shall be given to students from socioeconomically disadvantaged backgrounds enrolled in the program.

#### Reginald C. and Thelma Fesmier Edson Scholarship Fund

Established in 1991, the purpose of this fund will be to provide scholarships for Jefferson Medical College students.

#### Robert and June S. Eyerly, DN Scholarship

Established in 2017 to assist students who have served in the military or are descendants of veterans.

#### Erich A. Everts, MD Scholarship

This fund, established in 2006 by Erich A Everts, MD, JMC '50, is intended to provide aid to students from the Commonwealth of Puerto Rico with demonstrated need.

#### Dr. Albert R. Feinberg Memorial Scholarship Fund

This fund was established in 1960 in memory of Albert R. Feinberg, MD, Class of 1924 by his friends. These scholarships are awarded on the basis of need to worthy students.

#### First State Orthopaedics Scholarship Fund

Established in 1990, the pledge was made by five orthopaedic surgeons from Wilmington, Delaware, with funds raised during the 41st Alumni Annual Giving Campaign. Three are Jefferson Medical College graduates: Dr. Stephen Hershey, Class of 1968, Dr. Michael J. Axe, Class of 1979, and Dr. Brent R. Noyes, Class of 1978. The purpose of this fund is to generate income for scholarships for Medical College students.

#### Russell C. Fischer Scholarship Fund

This fund was established in 1978 to provide scholarship or other financial aid for students of the medical college.

#### Thomas W. Fiss, Jr., MD '71 and Joan S. Fiss Scholarship

Established in 2016, to provide scholarships to medical students with a preference for students from Delaware.

#### Dr. John A. and Linnea J. Forchetti Scholarship Fund

This fund was established in 2007 to provide scholarships to Jefferson Medical College students based on demonstrated financial need and high academic standing.

#### Fost Family Scholarship Fund

The Fost Family Scholarship is a need based scholarship to support New Jersey medical students.

#### Agnes Joern Fowler Scholarship

This fund was established in 1996 for the purpose of assisting medical students.

#### Irfan Galaria, MD SKMC '01, MBA and Noreen Galaria, MD SKMC '01 Scholarship

Established in 2018 to provide scholarships to students in the Sidney Kimmel Medical College. In order to assist the College in achieving a diverse student body, first preference shall be given to Muslim students with Middle Eastern, African, or Asian family origins, with a second preference for African American students.

#### General Scholarship Fund

Established in 2014, this fund was created for the purpose of assisting students. This scholarship is awarded annually to students with demonstrated financial need.

#### Dr. Karen Moss Glaser Memorial Scholarship Fund

Established in 2015, to be awarded to a fourth year female student based on demonstrated institutional commitment, participation in extracurricular activities and community service. Interest in Family & Community Medicine, Psychiatry or Pediatrics preferred.

#### Gozon Leaders in Medicine

Established in 2021, this program is designed to identify and nurture innovative and pioneering leaders in Medicine. Specifically, the Fund will provide financial aid to students entering their second year with renewal for third and fourth years if the students remain in good academic standing. Selection will be made by committee.

#### Greater Washington, DC Regional Scholarship

This fund was established in 2011 by Jefferson Medical College alumni in the greater Washington, DC area. This scholarship is awarded each year to a Jefferson Medical College student(s) from the greater Washington, DC area with demonstrated financial need.

#### Celia Goldberg Scholarship Fund

This fund was established in 1977 to provide aid to third or fourth year medical students with an interest in the field of endocrinology.

#### The Everett J. and Marian Gordon Scholarship

Established in 2012, this scholarship is to be awarded to Jefferson Medical College students with demonstrated financial need who are making satisfactory progress toward their degrees.

#### The Everett J. and Marian Gordon Scholarship

Established in 2012, this scholarship is to be awarded to Jefferson Medical College students with demonstrated financial need who are making satisfactory progress toward their degrees.

#### Philip Green, MD '56 Scholarship

Established in 2015, to provide financial support to students with demonstrated financial need.

#### Nancy S. Groseclose Scholarship Fund

Established in 1990, in memory of Nancy S. Groseclose, Executive Director Emeritus of the Jefferson Medical College Alumni Association, the purpose of this fund is to generate income for scholarships for Medical College students.

#### Kathleen S. and David M. Guarnieri Scholarship Fund

This fund was established in 2009 for the purpose of assisting medical students.

#### Carl M. Hadley, MD Scholarship Fund

This fund was established in 1995 to provide scholarships to deserving students in the Medical College based on financial need.

#### W. T. Hamilton, MD, Scholarships

Four funds were established in 1959 by bequest of William Thomas Hamilton, MD, Class of 1887, for the education and maintenance of deserving students whose financial means are limited.

#### Nancy W. and H. Roger Hansen, MD '69 Scholarship Fund

Established in 2020, this need-based renewable scholarship will be awarded annually with a preference for one student enrolled in the Design (DES) Scholarly Inquiry Track in the JeffMD Curriculum.

#### W. Paul Havens Scholarship Fund

This fund was established in 1991 for the purpose of providing scholarships for Medical College students.

#### Edward F. Hemminger, MD, Scholarships

This fund was established in 1960 by bequest of Edward F. Hemminger, MD, Class of 1908, to aid students to whom financial assistance is essential in acquiring a medical education.

#### Florence Henderson Scholarship Fund

This fund was established in 1976 by the will of Florence Henderson which provides funds for students with financial need. Preference is given to students who have graduated from New Castle High School, New Castle, Pennsylvania.

#### Dr. Louis Thales and Mary Sloan Hess Scholarship

This fund was established in 1955 by bequest of Louis Thales Hess, MD, Class of 1895, for medical education of any deserving male persons who are without adequate financial means to obtain such an education.

#### Heyt Family Scholarship

Established in 2021, this Scholarship will be awarded annually to two students and it is the Donors' preference to support one student with financial need and one student based on merit. It is also the Donors' preference that this Scholarship follow both students throughout their time in medical school over the course of four years.

#### Maury Hoberman, MD '60 Scholarship Fund

Established in 2020, this need based scholarship will be awarded annually and renewed to one medical student, with a preference for students who completed their undergraduate studies at West Chester University.

#### Nathan Samuel Housman, MD, Memorial Scholarship Fund

This fund was established in 1960 by bequest of Mrs. Lillie Housman as a memorial to her son, Nathan Samuel Housman, MD, to aid deserving students in the furtherance of their studies.

#### Katharine A. Howell Scholarship Fund

Established in 1991, the purpose of this fund is to provide academic scholarships for Medical College students.

#### Jesse Hubschaman Scholarship Fund

This fund was established in 2010 to provide scholarships for students in Jefferson Medical College.

#### Morris Ivker, MD Memorial Scholarship

This fund was established in 2007 to provide scholarships to a third or fourth year medical student with greatest financial need, who has met all applicable academic and other requirements, as a full-time student at Jefferson, throughout his or her attendance. Preference will be given to a student who may also have had a unique educational, career, or life experience.

#### Algernon B. Jackson Scholarship Program

Established in 1993, this award provides partial tuition scholarships to students who qualify as underrepresented in the field of medicine or are disadvantaged per federal guidelines. Scholarships are based on merit and/or financial need and will be renewed for a maximum of four years contingent upon the awardee successfully progressing to the next academic level. This program is supported by college operational funds and SKMC endowments.

#### W. Robert Jacobs Memorial Scholarship Fund

This fund was established in 1994 in memory of W. Robert Jacobs, MD, JMC '54 for the purpose of assisting a financially needy and deserving student who is planning to practice in Family Medicine.

#### Shailen Jalali, MD '85 Scholarship Fund

This fund was established in 2017, for the purpose of providing scholarships to students with financial need, with preference for Jefferson legacy students from the state of New Jersey.

#### Jefferson Medical Student General Scholarship Fund

This is a general scholarship fund established in 1960 by approval of the Board of Trustees.

#### William D. and Sally C. Johnson Family Foundation Scholarship Fund

This fund was established in 2016, for the purpose of providing need-based scholarships to students with a preference for female students in the Physician Shortage Area Program (PSAP).

#### Madeline C. and Dorothy H. Johnston Scholarship Fund

Established in 1977, the fund provides an annual scholarship that is awarded to one or more worthy women medical students at Jefferson Medical College.

#### Dr. Robert K. Josloff '89 and Sharon Josloff Scholarship

Established in 2014, the purpose of this fund is to provide support in the form of a scholarship award to a Sidney Kimmel Medical College student with demonstrated community service.

#### Caroline Kimmel Endowment Fund

Established in 2015, this scholarship is awarded to attract the top medical students who exhibit both high intellectual and emotional intelligence.

#### Dr. Chang Ha Kim/Southwest Hospital Foundation Scholarship

This fund was established by Dr. Kim, a member of the Southwest Hospital Foundation. First consideration for scholarship awards is to be given to students of Korean nationality or heritage. Should

there be no Korean students enrolled in the Medical College, awards may be made to students of Asian descent and to other students, in that sequence.

#### Charles Klieman, MD '67 Scholarship Fund

Established in 2018, this scholarship provides a need based scholarship to a student in the Medicine+Design Program. The same student may receive the scholarship in subsequent years provided he or she has demonstrated some form of significant progress in innovation.

#### Lorraine C. King, M.D. Scholars Scholarship Fund

This fund was established in 2016, for the purpose of providing scholarships to students within the Innovation & Design Application (IDeA) Program of SKMC.

#### David P. Kleinman Scholarship Fund

This fund was established in 1974 by Mrs. David P. Kleinman in honor of her late husband to perpetuate his interest in medicine. Awards are to be made to deserving students.

#### The Herbert Klemmer, MD and Jo Ann Klemmer Scholarship Fund

This fund was established to provide scholarship funds to deserving Jefferson Medical College students who show demonstrated need and are making successful progress in their studies. Preference is given to students planning to pursue the specialty of psychiatry.

#### Samuel Krain, MD '61 Scholarship

Established in 2014, this scholarship shall be awarded to medical students with demonstrated financial need.

#### Frank Winfield Laidlaw, MD Memorial Fund

This fund was established in 1950 by bequest of Sylvia N. C. Laidlaw as a memorial to Frank Winfield Laidlaw, MD, Class of 1903, to aid worthy students who are in real need of financial aid.

#### Helen and Gabriel Lavine Scholarship Fund

This fund was established in 1981 to provide scholarships to medical students.

#### The Fran and Leon L. Levy Endowed Scholarship

Established in 2013, this scholarship is to be awarded to students in Jefferson Medical College.

#### Bryan D. Lerner, MD '18 Memorial Scholarship Fund

Established in 2019, this scholarship shall be awarded to students from Delaware with preference for students pursuing a career in internal medicine and a history of community service work.

#### David J. Lieberman, MD Scholarship Fund

Established in 2002, this fund provides assistance to Jefferson Medical College students who are also graduates of Central High School, Philadelphia, PA.

#### Amy and Henry R. Liss Scholarship

Established in 1991, the purpose of this fund is to provide financial aid each year to one or more deserving students with demonstrated need.

#### Liss Scholarship Fund

This scholarship was established in 2009 to provide scholarship aid to Jefferson Medical College students with demonstrated financial need and a strong inclination toward the practice of family medicine.

#### Evelyn Livingood Scholarship

This scholarship is awarded annually to students with demonstrated financial need.

#### Lundberg Memorial Scholarship Fund

This fund was established in 1977 by George Lundberg, MD, Class of 1919 in memory of his beloved wife. Awards are to be made to one or more worthy medical students at Jefferson Medical College.

#### DeForrest W. Marchant, Jr., MD '85 Memorial Scholarship

This fund was established in 2005 by Betty Lou Marchant, MD and members of her family in memory of DeForrest Marchant, Jr., MD Awards are to be made to medical students demonstrating financial need and who have an interest and aptitude for obstetrics and gynecology.

#### Joshua A. Marks, MD Scholarship

Established in 2014, this scholarship is awarded to medical college students with financial need and incurred debt, making satisfactory academic progress, having demonstrated a commitment to the care of critically ill or injured patients and who are entering a surgical specialty such as general surgery, neurological surgery, orthopaedic surgery, trauma, emergency general surgery or surgical critical care. While these surgical specialties are preferred, a specialty in emergency medicine may qualify.

#### Phillip J. Marone, MD Scholarship

Established in 2013, this scholarship is to be awarded to a student in Jefferson Medical College with demonstrated financial need.

#### Phillip J. Marone, MD, MSPH and Carmela L. Marone Scholarship

Established in 2018, this gift shall be used to provide need-based scholarships for students in good academic standing.

#### McCorvey-Higginbotham Scholarship

Established in 2020, this scholarship provides need-based scholarships to assist the College in achieving a diverse student body, preference shall be given to African American students, with a second preference for students who have attended Tuskegee University, and a third preference for students who have attended any historically Black college or university (HBCU). It is also the Donor's preference that the students are from the southeast region of the United States, or California, or Texas, and that one (or more) first year students receive the scholarship for their entire four years at Jefferson.

#### J. Ewing Mears Scholarship

Established in 2015 to provide financial support to Sidney Kimmel Medical College students with demonstrated financial need. Preference will be given to those students with an interest in art in medicine.

This revolving fund was established in 1942 by a grant from the W. K. Kellogg Foundation.

#### James M. Large Loan Fund

The James M. Large Loan Fund was established in 1984 by Provident National Bank to provide loans to needy Jefferson students.

#### Leo M. Levi, MD Student Aid Fund

This fund was established in 1963 by bequest of Alma L. Weixelbaum as a memorial to her nephew, Leo M. Levi, MD, Class of 1927, to provide financial assistance to worthy students.

#### Thomas Rogers Morgan Loan Fund

This fund was established in 1983 to provide financial assistance to students at Jefferson Medical College by the giving of scholarships or the making of loans or grants. This gift is made in memory of Dr. Thomas R. Morgan who graduated from Jefferson Medical College in 1916.

#### Edward S. Phillips Loan Fund

This fund was established in 1982 to provide loans to needy students, preferably from West Virginia, of high character and scholastic ability.

#### PNC Loan Fund

Established in 1996, this fund is awarded to financially needy medical students to help meet educational expenses.

#### Dr. David Promin Student Aid Fund

This fund was established in 1956 for needy students by Mrs. David Promin in memory of her husband, David Promin, MD, Class of 1927.

#### Marshall C. Rumbaugh Loan Fund

Established in 1983, this fund provides financial assistance to Jefferson Medical College students.

#### Jefferson Medical College Student Loan Fund

This general loan fund was established in 1960 by approval of the Board of Trustees.

#### James Simpson, MD Student Loan Fund

This fund was established in 1964 by bequest of Annie Simpson as a memorial to her brother James Simpson, MD, Class of 1865, for loans to needy students.

#### Dr. Samuel D., Martha B., and Mabel I. Sledd Foundation Loan Fund

This fund was established in 1967 by bequest of Mabel Sledd Cunnison to aid worthy students in need of financial assistance.

#### Melba W. Snyder Student Loan Fund

This fund was established in 1991 for the purpose of providing interest-free loans to Jefferson Medical College students and nursing students of the College of Health Professions.

#### Jean and Joseph Stefansky Memorial Fund

This fund was established in 1983 for the purpose of "assisting and helping needy young men and young women in securing an education and training for the medical profession."

#### Thomas Jefferson University Loan Fund

Established in 1982, this fund helps defray interest expense for students acquiring loans through cooperating banks, or making direct loans to students.

#### Mabel J. Wayland Student Loan Fund

This fund was established in 1970 by a bequest from the estate of Mabel J. Wayland in memory of Leslie J. Graham, Julia L. Graham, and Raymond T. Wayland, MD, to be used as loans to needy students in amounts not to exceed \$1,000, to be paid back, interest free, within three years after the student is in practice.

#### Rosemary G. Wilson Loan Fund

This fund was established in 1982 by Rosemary G. Wilson in memory of her father P. Charles Green, Class of 1893, to help needy students.
